It has the following wings headed by Diplomatic officers: (i) Administration /Chancery Wing (ii) Consular Wing (iii) Economic &amp; Commerce Wing (iv) Political Wing (vi) Information, Culture and Education Wing</p> <p>The functions of the High Commission, inter alia, include political and economic cooperation, trade and investment promotion; cultural interaction, press and media liaison in the bilateral and multilateral contexts.</p> <p>High Commission functions within the purview of business allocated to the Ministry of External Affairs under the Government of India's Allocation of Business Rules and Transaction of Business Rules.</p>
(ii)	The powers and duties of its officers and employees;	<p>General Administrative powers are derived from IFS (PLCA) Rules, as amended from time to time. Financial powers of the Officers of the Embassy of India have been detailed in the Delegated Financial Powers of the Government of India's Representatives Abroad.</p> <p>Other powers are derived from the Passport Act of India.</p> <p>The Officers of the High Commission function under the guidance and supervision of High Commissioner.</p>
(iii)	The procedure followed in the decision-making process, including channels of supervision and accountability;	Decisions are taken under the instructions and supervision of the High Commissioner.
(iv)	The norms set by it for the discharge of its functions;	Norms are set under the instructions and supervision of the High Commissioner.

(vii)	The particulars of any arrangement that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or implementation thereof;	High Commission of India functions within the norms of India's foreign policy formulated by the Ministry of External Affairs. Policy is implemented by the High Commission under the guidance and supervision of the High Commissioner.
(viii)	A statement of the boards, councils, committees and other bodies consisting of two or more persons constituted as its part or for the purpose of its advice, and as to whether meetings of those boards, councils, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public;	High Commission interacts regularly with representatives of think tanks, academic community and others.
